MPS Amendments Regarding Public Participation Program

- Hantsport, Windsor and West Hants each had a Public Participation Program Policy for many years
- December 2019 “Engagement Programs Content Regulations made under Section 204A of the Municipal Government Act” require all Municipal Planning Strategies to contain policy referring to the Public Participation Program Policy
- April 28, 2020 Council approved a Public Participation Program Policy for the Region; it reflects the policies earlier developed by the individual units

MPS Amendments regarding Public Participation Program

- there is no reference to the Public Participation Program Policy in any of the current Municipal Planning Strategies
- there are no policies within the Municipal Planning Strategies for Hantsport, West Hants or Windsor which must be considered in relation to the proposed amendments since this policy reflects process rather than any other content



Public Participation Program Policy Amendments

- in addition, the *Engagement Programs Content Regulations* require that the Public Participation Program Policy states how a municipal unit will advise abutting municipal units of a proposed Municipal Planning Strategy or amendments
- Policy must ensure that the notice allows ample time for the abutting municipalities to comment on proposed changes before Council holds “First Reading”, or announces its intention to adopt or amend a Municipal Planning Strategy
- revisions will be needed to the Public Participation Program Policy
