The Permit Holder Shall:

1. Contact the West Hants Regional Municipality (WHRM) Waste Services Coordinator prior to the date of the event to complete Litter Clean-Up Permit. Arrangements will be made for pick-up of sufficient numbers of

safety vests, garbage bags, and other supplies available at the time.

2. Contact the WHRM Waste Services Coordinator after completion of event to arrange for return of safety vests, unused garbage bags and all other materials, and to report any large animal carcasses and hazardous substances or containers found and flagged. Photos taken during the event that you would like to share with the community are welcome at this time.
3. Save and hold harmless WHRM and the WHRM Traffic Authority against any and all claims for personal injury and/or property damage to whatsoever nature, both during and after the execution of the work covered by this permit wherein, in the opinion of the Municipality, any such claim arises from the execution of the work.
4. Ensure the applicant or some other responsible authority, is present at all times during the event to ensure compliance with conditions listed below.

THIS PERMIT IS ISSUED UNDER THE FOLLOWING CONDITIONS:

1. No portion of the event may take place directly on municipal streets unless special permission is granted. The roadway will be kept open for normal traffic movement at all times, and vehicular traffic will not be obstructed in any manner.
2. The participants must obey all applicable provisions of the Motor Vehicle Act at all times. This permit does not convey any special privileges or rights to exempt any portion of the Act.
3. It shall be the responsibility of the applicant to ensure that all necessary safety precautions are taken to ensure safety of the participants and all other bystanders within the event area.
4. Each child under the age of 8 participating in the event must be accompanied by one adult. Every six participants under the age of 16 must be accompanied by one adult (18 years or older).
5. Confine event to the section registered to the sponsored group.
