APPOINTMENT OF DEVELOPMENT OFFICERS EXCERPT

Following the departure of the Municipality's fully appointed Development Officer in November 2025, William Overholt has been serving in an acting capacity as the sole Development Officer, maintaining service levels and supporting staff training. To strengthen capacity and leadership within Development Control Services, Derek Robertson has been hired as Manager of Development Control Services, with a start date of January 21, 2026. Given their qualifications, experience, and roles in administering the Municipality's Land Use and Subdivision By-laws, it is appropriate that both individuals be formally appointed as Development Officers to ensure continuity of service, effective by-law administration, and organizational resilience.

Subject: Appointment of Development Officers

LEGISLATIVE AUTHORITY

Nova Scotia Municipal Government Act, Section 243, Development Officer

DECISION REQUEST

It is recommended for Committee of the Whole recommend that:

...that Committee of the Whole recommends that Council appoint William Overholt and Derek Robertson as Development Officers effective January 28th, 2026 in accordance with Section 243 of the Municipal Government Act.

BACKGROUND

In September 2025, Council designated William Overholt as the Alternate Development Officer and since the departure of the fully appointed Development Officer in November 2025 he has been acting as the sole Development Officer appointed to administer the Land Use By-law's and Subdivision By-law's of the Municipality. Since taking over, William Overholt has maintained regular levels of service and has begun training the new Development Control Technician,

Melanie Kennedy. To fill the recent vacancy, the department has hired Derek Robertson as Manager of Development Control Services who will begin employment on January 21st, 2026.

In anticipation of the new Manager of Development Control Services starting in mid-January, both William Overholt and Derek Robertson should be appointed as Development Officers. At the September 2025 Committee of the Whole meeting, it was stated that that a request to fully appoint William Overholt as Development Officer would be submitted to Committee of the Whole at later date.

DISCUSSION

Development Officers administer the Land Use By-law's and Subdivision By-law's of the Municipality which includes responding to general property inquiries, writing zoning confirmation letters, issuing development permits for as-of-right development, and approving plans of subdivision. The authority to administer these by-laws is delegated by Council to ensure efficient, expert, consistent, and legally sound decision-making. It is reasonable to appoint all staff with training, education and experience to maintain a high level of service and to be prepared for any unexpected extended leave and vacations.

William Overholt was hired in April 2025 and had been training with the previous Development Officers up until November 2025 where he became the sole Development Officer, in an acting capacity. William is a qualified planner/development officer with over 2 years of experience in a municipal role. William also holds a Master of Environmental Studies, Planning and is currently working towards his designation with the Municipal Development Officers Association of Nova Scotia and as a License Planner with the Licensed Professional Planners of Nova Scotia. William is highly competent in his work and has shown a high degree of professionalism in his role with West Hants Regional Municipality.

Derek Robertson was recently hired as the Manager of Development Control Services to replace the recent vacancy. The manager position was created to strengthen leadership, consistency, and capacity within the development services unit following the departure of the previous Development Officer. The role provides experienced oversight of land use by-law administration, supports mentoring and training of junior staff, and ensures complex, or high-

impact development applications are managed effectively. In addition, the manager will serve as a key liaison with major developers and other stakeholders, helping to improve communication, coordination, and the overall quality and timeliness of development decisions. Derek Robertson comes to the municipality with a Bachelors of Community Design from Dalhousie University, and several years of experience in a leadership role in both the private and public sector. He has acted as a Development Officer in both of those capacities for municipalities in Nova Scotia.

Formal appointments of Derek Roberson and William Overholt as Development Officers are necessary to support the effective administration of the applicable by-laws and the duties assigned to their positions.

FINANCIAL IMPLICATIONS

There are no financial implications related to the appointment as the salary is established within the budget.

ALTERNATIVES

COTW could recommend that Council not appoint Derek Robertson and William Overholt as Development Officers, resulting in an inability to administer and enforce the Land Use By-law's and Subdivision By-law's of the Region in a timely manner in the absence of a fully appointed Development Officer.

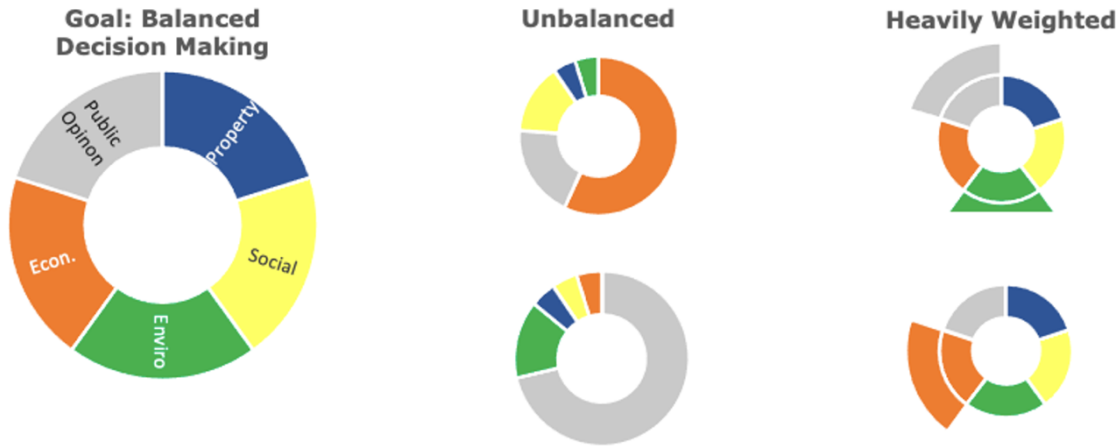
