The Accessibility Advisory Committee (AAC) provides advice to Council on identifying, preventing and eliminating barriers to people with disabilities in municipal programs, services, initiatives and facilities and plays a pivotal role in helping to become a barrier-free community and ensuring obligations under “An Act Respecting Accessibility in Nova Scotia (2017)” are met.

The committee consists of no less than seven (7) members as follows:

- One (1) members of Council and One (1) Alternate – Two (2) year term
- No less than Four (4) Resident members – Two (2) year term

- No less than Two (2) Resident members – Three (3) year term

Ms. MacAskill's term will not expire until January 31, 2026, and Ms. Davison's appointment does not expire until January 31, 2027 which leaves up to three (3) - two (2) year term vacancies to be filled and one (1) – three (3) year term vacancy to be filled.

As identified in the Terms of Reference, at least one half of the members of the AAC must be persons with disabilities or representatives from organizations representing persons with disabilities.

DISCUSSION

Members were notified of the approaching end of their term and were encouraged to apply for the upcoming term.

Public advertisement for resident members was placed in the local paper (the Valley Journal Advertiser), on the Municipal website and Facebook page on October 15, 2024. Applications to be a resident member of the Accessibility Advisory Committee were accepted until 12 p.m. (noon) October 30, 2024.

Once approved by Council, all applicants will be contacted to notify them of whether or not they were appointed. Required additional information will be sent to new members.

Resident members appointed to a Committee of Council will receive remuneration in accordance with the Council Remuneration Policy, which is identified in the annual Operating Budget.
