Subject: Buyout Policy Committee and Funding Request

LEGISLATIVE AUTHORITY

Municipal Government Act

RECOMMENDATION or DECISION REQUEST

Council direct staff to create a temporary “Buyout Policy” committee consisting of Districts 10 & 11 Councillors, 4 citizen members, and West Hants staff to complete the draft Buyout Policy for councils' consideration.

Further that

Council direct staff to write a letter to the Province of NS and Federal Government of Canada formally requesting financial support with the funding of a Buyout Program.

BACKGROUND

In recent months, Council has been working through a draft Buyout Policy for it to consider. The process has been good with councillors contributing to different points at every meeting. Recently, residents who would be considered in a potential buyout program reached out wanting to meet with the Councillors in Districts 10 & 11, the CAO, and myself. At the meeting it was suggested that it may help speed up the development of a potential policy, for council consideration, if a committee was formed rather than council working through the policy bit by bit at each passing meeting. With Council being the only decision-making authority, I agreed to put the suggestion forward.
